2:00 pm	Starting and Running an Effective Safety Program Jonathan Wright – City of Chesapeake In 2016 OSHA placed restrictions on a company's use of incentive programs that could be construed as punitive or could lead to the under reporting of accidents and injuries. Chesapeake Public Utilities' Safety Incentive Program fell under this restriction and had to be modified to bring it to current standards. On August 31, 2016, we implemented a new Safety Recognition Program that encouraged both proactive reporting of hazards before accidents could occur and safe work practices that go above employees normal responsibilities.


